

- o Ages 5 –7 Small Boards
- o Ages 8 12 Medium Boards
- o Ages 13 Above- Large Boards
- o Athletes get 2 chances to break their boards- 30 Second Time Limit*
- o All Color Belts- 3 Boards Maximum \$3.00 per board
- o All Black Belts- Maximum 5 boards \$3.00 per board
- o No Chairs or Props allowed
- o Athletes must provide their OWN HOLDERS
- o Athletes may NOT bring their own boards- Boards will be sold onsite.
