- o Athletes will be judged on – technique, speed, power, creativity, and number of attempts.
  
- o Ages 5 –7 – Small Boards
- o Ages 8 – 12 – Medium Boards
- o Ages 13 Above- Large Boards
  
- o Athletes get 2 chances to break their boards- 30 Second Time Limit
- o All Color Belts- 3 Boards Maximum - \$3.00 per board
- o All Black Belts- Maximum 5 boards - \$3.00 per board
- o No Chairs or Props allowed
- o Athletes must provide their OWN HOLDERS
- o Athletes may NOT bring their own boards- Boards will be sold onsite.
